**AN ORDINANCE OF THE TOWN OF HAMPDEN CREATING
CHAPTER 9 OF THE MUNICIPAL CODE OF THE TOWN OF
HAMPDEN ENTITLED TRAFFIC REGULATIONS**

CHAPTER 9

TRAFFIC REGULATIONS

Section 9.1. Regulation of Parking.

A. Temporary Parking Prohibited. No person shall at any time park, stop, or leave standing any Vehicle used for the purpose of loading and unloading any Agricultural Product, along any improved road or unimproved portion of the road right of way subject to the Town's jurisdiction.

B. Removal of Vehicle. If a Vehicle is parked in violation of this Ordinance, the Traffic Officer is authorized to move the Vehicle or to require the operator in charge thereof to move the Vehicle to a position where parking is permitted or to either private or public parking or storage premises. The removal may be performed by, or under the direction of, the Traffic Officer or may be contracted for by the Traffic Officer. The operator or owner of the Vehicle removed shall pay the reasonable charges for moving, towing or any Vehicle storage involved, and shall pay these costs before the Vehicle is released.

C. Notice. On or before August 15 of each year, the Town Clerk shall publish a Notice in the official newspaper for the Town regarding the requirements of this Ordinance. This publication by the Town Clerk shall serve as presumptive notice to the general public.

D. Definitions.

1. **Agricultural Product.** Any plant or part of a plant, including grains, animal or animal product, produced primarily for sale, consumption, propagation, or other use by humans or animals.

2. **Traffic Officer.** The Town Chair of the Town of Hampden, the Town Constable, or any other Law Enforcement Officer.

3. **Vehicle.** "Farm Truck", "Tractor-semitrailer combination", "Trailer" and "Vehicle" as those terms are defined in Chapter 340 of the Wisconsin Statutes with an unloaded gross weight of more than 10,000 pounds.

Section 9.2. Penalty

Any person violating the provisions of Section 9.01 shall be subject to a penalty of between \$20.00 and \$40.00 for a first violation and \$50.00 and \$100.00 for each and every subsequent violation within a year of the first offense. Pursuant to Section 8 of this Code, the deposit for a first violation shall be \$40.00 and \$100.00 for each and every subsequent violation within one year of the first violation.
