The Town of Hampden resolves to adopt the following fee schedule for Chapter 7 Land Division and Subdivision Regulations, Chapter 11 Solar Energy Systems Licensing, Chapter 14 Right of Way Control, Chapter 16 Wind Energy System and Other Miscellaneous Fees to be effective as of February 17, 2026.

<b>Chapter 7 Land Division and Subdivision Regulations</b>		
<b>Escrow Fees</b>	\$300- \$1000	Due at time of application and are used for Public Hearings, Attorney Fees, Recordings, or other charges directly related to individual's application.

Note that Township fees are in addition to County fees.


