Chairman Grove turned the hearing to **David Mickelson**. The Mickelsons proposed to create a 4.5-acre lot around the existing residence on parcel 380 that will front on Mickelson Drive. The proposed lot will be rezoned to the RR-1 Rural Residence district. The remnant 35.5 acres of parcel 380 will remain zoned A-1 Agriculture. To maintain a density of one home per 35 acres in the Town of Hampden for the existing home, all 40 acres of parcel 360 will be restricted from further residential development by rezoning to A-1 Agriculture with A-4 Agricultural Overlay.

The commission asked some questions about the rezoning.

Grove asked if any questions from the public and there were none. The request was not contested.

Dahl made a motion to adjourn the public hearing. Virgin seconded. The public hearing adjourned at 6:12pm
