Citizen Comments/Correspondence:

A permit from Charter Spectrum was presented to do work in the township starting around May 1, 2024 with an estimated completion date of 12-30-2024.

Wisconsin Towns Association district meetings have started which will include BOR training.

Chairman Report:

The parking lot at the Hampden Leeds Recycling Center will be expanded.

John Kraus from Columbus Rural Fire Group is working on the fire truck purchase between the fire group and City of Columbus.

Crombie Lawn Care will do the mowing for 2024.

Plan Commission Report:

Dahl reported that a plan commission meeting was held Tuesday, January 16, 2024. Scott Sharpee was there to get information about what needs to be done to build a house on property in the township.

Also started reviewing the Town of Hampden Comprehensive Plan – State Statues state that comprehensive plans need to be reviewed every ten years. County Supervisor Andrew Groves attended the meeting to give the plan commission some guidance/direction on how to start.

Road Maintenance:

A lot of complaints about snow plowing. Tuschen stated he kept in contact with the County Highway Department, they are doing their best with the help they have.

Other Business:

Dahl made a motion to accept the bid to paint the inside of the town hall from Brian Hall and not to exceed \$4000.00 Hoffman seconded the motion.

Hoffman made a motion to replace the toilets in all three bathrooms and cap off the water lines to the bubbler using the quote from Arlington Hardware Co., Dahl seconded the motion.

Cole Cemetery was discussed. It is an abandoned cemetery in the township, off Hall Road. The owners of the lands around the cemetery (Jr and Sherry Manthe) would like to clear the trees and brush on their land that is around the cemetery and if the town would approve, they would clear the cemetery also. They would respect that it is a cemetery. They would cut the trees and grind the stumps in the cemetery.

Hoffman made a motion to approve the clearing of the trees and grinding the stumps in Cole Cemetery at a cost not to exceed \$4500.00. Dahl seconded the motion. Dahl will mark the corners of the cemetery.

Hoffman made a motion to adjourn the meeting, seconded by Dahl. The meeting adjourned at 7:00 p.m..
