Dahl made a motion to approve the bills, seconded by Hoffman. Motion carried.

Citizen Comments/Correspondence:

Guenther reported on the election on April 2, 2024. There were 149 voters, 17 were absentee ballots.

Chairman Report:

Tuschen stated that the joint meeting with the Town of Leeds, Lowville, and Arlington is still on hold, no updates.

Plan Commission Report:

Dahl reported on the plan commission meeting that was held on April 8th, 2024. It was scheduled for Olin Selje. He would like to create a couple of lots on his property of 116 acres. It was an informational meeting for him.

Dahl also stated that the members discussed the Hampden Comprehensive Plan. They are not sure what to do so will be contacting Columbia County Supervisor Andrew Groves for some guidance.

Road Maintenance:

Tuschen will search out getting estimates for town road repairs.

Tuschen delivered the Bridge/Culvert Program form to Chris at the Columbia County Hwy Dept.

Other Business:

The board discussed the bids for the Hampden-Leeds Recycling Center parking lot. Hoffman made a motion to accept the bid from Denure in the amount of \$16,425.00, to be split between Town of Hampden and Town of Leeds, Dahl seconded the motion, motion carried. The County Hwy Dept will put the culvert in for the additional driveway, at an additional cost, also being split between Hampden and Town of Leeds.

The board looked at an estimate for a Shelter behind the town hall – no decision.

The board discussed having the fence line along the town hall and cemetery cleaned up more. Hoffman made a motion to have Travis Johnson work on the project, seconded by Dahl.

The Mobile Home Verification for 2024 was reviewed and approved. There is one mobile home in the township owned by David and Nancy Huebner and it is used for farm labor.

Open Book is scheduled for April 17, 2024 from 2:00-4:00 pm at the Hampden Town Hall and the Board of Review is scheduled for April 25th, 2024 starting at 5:30 pm at the Hampden Town Hall.

The next town board meeting will be May 21, 2024 at 5:30 pm

Dahl made a motion to adjourn the meeting, seconded by Hoffman. The meeting adjourned at 6:30 p.m..
