General Engineering has a new fee schedule.

Diane Guenther submitted her letter of resignation which will be effective after the December 17th town board meeting.

Chairman Report -

Directors attended the Columbia County dept meeting. Discussions included bridge work, County Road A work in 2026, and other road work. The Town of Hampden will have 3 signs replaced/repaired as part of winter projects.

The Rio and Columbus Fire budgets were approved.

The Recycling Center will be closed this Saturday, 11/23/24.

Chairman Tuschen did a tour with TNT Lawn Care of the deadend roads for snowplowing this winter. Plowing will include 2"+ of snow and blowing/drifting snow will be on-call basis.

Chairman Tuschen attended an Alliant Energy meeting last week relating to wind towers. Mid-2025 a proposal will be prepared for the planning commission. If approved, planning will begin in 2027 and wind towers will be built and in use for power in 2028. There will be 40 towers in total and placement is not final.

Plan Commission -

Reviewed land division for Paul and Donna Sharpee to create a 5 acre lot with an existing house and outbuildings located at N1024 County Road N and deed restrict the remaining parcel, 34.79 acres, from further residential development by rezoning to A-1 Ag with A-4 Overlay.

Hoffman made a motion to approve the land division as proposed. Seconded by Dahl. Motion passes.

Road Maintenance -

The town replaced 7 culverts this year.

The board to consider additional winter projects for Columbia County Hwy Dept.

Other Business -

Hoffman made a motion to approve the Memo of Understanding between Town of Hampden and Columbia County for WisVote service. Seconded by Dahl. Motion passes.

Dahl made a motion to approve the 2025 Budget for \$495,272. Seconded by Hoffman. Motion passes.

American Rescue Plan Act (AARPA/Covid) funds will be reserved to pay for the town's allocation of the new Columbus fire truck (in 2026) and the remaining funds to help pay for a new town shelter. The contract for the shelter was signed. Funds will need to be obligated by the end of the year.
