### **Call to Order -**

Chairman Tuschen called the meeting to order at Call to Order at 5:32pm.

### **Roll call -**

Town board members present - Chairman Tuschen, Supervisor Taylor Dahl, Supervisor Bill Hoffman, and Clerk Nanette Hensen. Treasurer Lori Toutant was not present. County Supervisor, Andrew Grove was also present.

- 2024 Department of Revenue Form CT Municipal Financial Report was filed 3/22/25.
- ARPA Expenditure Report was filed on 4/1/25 with the Columbus Fire Truck assessment and Town Shelter as basis for obligated funds.
- Hensen, clerk, will be on a temporary absence from the end of May to 1st week of June. Citizens to contact Dave Tuschen directly for immediate concerns during this time.
- Election equipment to be serviced at the end of May. Hoffman to pick up equipment from county since Hensen will be out.
- Hensen presented a cost analysis comparison of paper checks vs. electronic payments. Given bank fees associated with electronic payments, the town will continue to use the less expensive paper checks.

### **Citizen Comments/Correspondents/Announcements -**

There was a citizen complaint about water run-off and the Board will follow up with a site visit.

### **Chairman Report -**

- The town hall Crombie Lawncare contract was signed for this season.
- Adams-Columbia Electric Cooperative contract was signed for 2025.
- For Memorial Day, the American Legion Post #62 will place flags for veterans in the Town cemetery for a donation of \$200 to cover this and last year. Going forward, the donation will be \$100 annually.
- Hoffman to follow-up with an inquiry from Town of Ostego about the Hall Road Cemetery clean-up.
- Hensen will post the Well Compensation and Well Abandonment Grant Programs notice on town sites for citizen awareness. Applications are due in August 2025.
- The Open Book will be held on Monday 5/12/25 10am-noon at the town hall.
- The Board of Review meeting will be held Tuesday 5/20/25 4-6pm at the town hall.
- Hensen will follow-up with Toutant for cyber security grant consideration.
- The Columbus fire department meeting was on April 4th at 7pm.
- Tuschen and Hoffman to attend Capitol Day 2025 hosted by WTA on 4/30/25.

- Tuschen to follow-up regarding a county letter relating to a septic permit and ERN notification.

### **Road Maintenance -**

- 4/2/25 Road Tour results and potential road expenditures for 2025 were discussed. The Board will review past maintenance and further discuss next month.
- Town of Bristol Comprehensive Plan was sent to Scott Grove to review.
- The Board attended the County Highway commission April meeting. The county presented the annual work map. The Board discussed adding a request for spraying for wild parsnip.
